The land has several thousand feet of winding river frontage along the Cucharas River which is a game haven for elk, mule and white tail deer, pronghorn, turkey, and waterfowl.

The property is large enough to offer great privacy, yet very convenient to local communities and amenities. Located on paved Highway 12, the property is just a short drive into the quaint town of La Veta. In addition, the property is only 1 hour to Pueblo, CO and under 2 hours to Colorado Springs. The 141 acres has significant winding river frontage and bottom land along the Cucharas River. River properties with acreage are rare to find in today's marketplace!

The land is located in Game Management Unit 85. The river bottom area provides water and forage for big game and bird life. This would be an ideal set up for bow hunting enthusiasts or turkey hunters with plenty of areas to have tree stands and blinds. The property is a recreational base for many activities with over 300+ days of sunshine and fresh mountain air. Enjoy horseback riding, hiking, ATV use, camping, hunting, or sightseeing along the Highway of Legends and the San Isabel National Forest and Spanish Peaks Wilderness.
