Improvements include a small hunting-blind style cabin, powered by a small generator. A perfect fit as a hunting basecamp. Set up as a camping getaway it has a wood burning stove and some minor amenities, all included to make the next owner's lives easier. GMU 581 is renowned for its abundant mule deer and turkey hunting opportunities, among other species of Colorado wildlife. Access to thousands of acres of public lands only minutes away. From the driveway it drops down into a hollow with several flat areas that could fit a separate small cabin. Heading South the property slopes upward from the hollow and is largely covered in tall/dense pine trees all the way up to the southern boundary which is primarily hillside. A 600+ acre parcel neighbors to the south of this property which ensures privacy and protected surroundings. The land is covered in towering Ponderosa pines, giving it a true mountain-retreat feel. This area is roughly 30 minutes to Canon City, an hour's drive to Woodland Park, and an hour and a half to Colorado Springs. The property's low tax burden is attributed to its agricultural zoning status and established grazing lease. Property is gated and has 4x4 access.
